Privacy Policy

Chapman's Bay Estate Home Owners' Association ("us", "we", or "our") is a home owners association that enforces the set of rules, policies and procedures, contained in their Constitution, that serves the best interests of the group of members of the Association.

Chapman's Bay Estate Home Owners' Association's ("Association") main object is the control over and the maintenance of buildings or structures, services and amenities on the common areas on the Estate, and more specifically:

Architectural Guidelines

• Representation

To comment to the City on whether building plans comply with the approved Architectural Design Manual.

Community

To promote, advance and protect the communal and group interests of the members of the Association and to promote harmonious living.

Common Area

To take transfer of the Common Areas and pay rates and taxes for such areas to the City.

Maintenance

To maintain all internal roads, private open spaces, and internal services on the common property and to assume liability for the street lighting.

Landscaping

To manage the landscaping of the common areas.

• Operational Environmental Management Plan ("EOMP")

To manage the Association in accordance with the OEMP.

Fire Safety

To ensure the compliance with all fire management plans in place for the Association.

6. Do Not Track disclosure

The security of your Personal Information is important to us, and we strive to implement and maintain reasonable, commercially acceptable security procedures and practices appropriate to the nature of the information we store, in order to protect it from unauthorised access, destruction, use, modification, or disclosure.

However, please be aware that no method of transmission over the internet, or method of electronic storage is completely secure and we are unable to guarantee the security of the Personal Information we have collected from you.

10. Links to other sites

Our site may contain links to other sites that are not operated by us. If you click on a third party link, you

will be directed to that third party's site. We strongly advise you to review the Privacy Policy of every site
